## **Walnut Street Garage Demolition**

The proposal from Boyle for the overview of the construction management of the demolition of the Walnut Street Garage at a cost of \$127,685. Mr. Jim Broughal asked if notices were going to be sent to the businesses and residents of Market Street to notify them of the demolition. Mr. Steve Fernstrom said the necessary steps will be taken to notify everyone. Ms. Lynn Cunningham asked for a motion to approve the proposal from Boyle. Mr. Mark Jobes made a motion, and Mr. Eugene Gonzalez seconded the motion. A motion was passed unanimously.

#### **Walnut Street Garage Development Funding**

Mr. Scott Shearer from PFM recommended the best route for the Bethlehem Parking Authority is to get a bank loan with no City guarantee. There will be multiple steps. The first would be a demolition loan and sending out an RFP for demolition financing of roughly around 2.2 million. This would be a subordinated loan. In February's Board Meeting, we'll look for the approval of financing with the bank with the best results for the loan. The second step would be to send another RFP for full financing of the entire garage and to pay off the demolition loan so it can all be rolled into one.

#### **THA Consulting**

Mr. Kevin Carrigan performed a condition assessment in all the garages and developed a five-year capital repair plan. The Commons Garage was the highest level of concern. It would be worked on in the first two years; thereafter, work will be performed in the Riverport Garage for three years and finish up with S. New Street and North Street Garages. The lower level of the Commons Garage will be worked on in the first year and then the upper level in the second year. Ms. Lynn Cunningham asked for a motion to execute the construction manager contract. Mr. Eugene Gonzalez made a motion, and Mr. Mark Jobes seconded the motion. A motion was passed unanimously. Mr. Steve Fernstrom said that it will be funded by the Capital Reserve Funding to avoid borrowing.

## **INVESTMENT OPPORTUNITY**

Mr. Chris Bentley reported that back in October, \$1,000,000 was put into a PSDLAF. A six-month US Treasury Security that will mature in April and accumulate \$28,000. We currently have \$2,000,000 in our bank accounts not earning interest. We are looking into putting \$1,000,000 into another PSDLAF six-month US Treasury Security or a Full Flex with a percentage of 4.66 for six months. Another option would be to spit it. Ms. Lynn Cunningham asked for a motion to approve putting \$1,000,000 into a PSDLAF six months US Treasury Security. Mr. Mark Jobes made a motion, and Mr. Eugene Gonzalez seconded the motion. A motion was passed unanimously.
